Each of the undersigned expressly acknowledges and agrees that the activities involved in the Event can be very dangerous and may involve the risk of serious injury, death and/or property damage. Each of the undersigned also expressly acknowledges that the risks associated with the event may include, but are not limited to falling off of or being thrown from animals, being trampled, kicked or bitten by animals, being involved in collisions involving animals, animal-drawn equipment, mobile equipment and/or vehicles, the failure of tack or equipment and other risks associated with the unpredictable nature of animals, and each of the undersigned expressly acknowledges and assumes these and other risks. Each of the undersigned further expressly agrees that this RELEASE OF LIABILITY is intended to be as broad and inclusive as permitted by the laws of the State of Washington, and that
